may use this form to ask the court to waive your court fees. The court may order you to answer questions about your finances. If the court waives the fees, you may still have to pay later if:

- You cannot give the court proof of your eligibility,
- Your financial situation improves during this case, or
- You settle your civil case for . \$10,000 . or more. The trial court that waives your fees will have a lien on any such settlement in the amount of the waived fees and costs.

### FW-001 Request to Waive Court Fees

The fee waiver applies to fees that the court charges in civil, family and small claims matters, except for: fees you pay to an individual who is independent of the court (e.g. lawyers, authorized court transcriptionists, official examiners, witnesses and mediators) fees relating to criminal matters

General exemption. A body or person is exempt generally from paying court fees in a proceeding if: the body or person has been granted legal aid for that proceeding from a State/Territory Legal Aid Office or an approved legal aid scheme or service (a list of approved legal aid schemes and services can be downloaded from this page);

### Exemption from paying court fees

If you don't have enough money to pay the court fees, you can ask a judge to waive the fees. Your fees should be waived if you can prove that any of the following are true: You get government benefits because you are poor (for example, food stamps, TANF, Medicaid, SSI or public housing).

A "waiver" means that the court has determined that you, the applicant, are not required to pay the fees unless your financial circumstances change during the case. For example, the court will normally grant a waiver if the applicant establishes by affidavit, with supporting documentation (e.g., eligibility letter), that he or she receives SSI benefits.
